Comment: COGCC records show well DA'd 12/11/2016. COGCC 1004.a requires reclamation work be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities. Gravel (tracking BMP) remains at access road and will need to be removed/reclaimed. Revegetation activities do not appear to have been conducted on location and access road. All reclamation work should have been completed by 12/11/2017.

Corrective Action:	Remove gravel and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To take advantage of the 2018 spring growing season, revegetation activities shall be complete no later than 3/31/2018.	Date	03/31/2018
