We will put down a soil amendment to reduce the alkalinity of the soil and then drill grass seed [PBSI.Native Pasture Mix - PB-39286-16]. After the seed has been planted we will crimp straw in the soil to prevent erosion. A request for final reclamation approval will follow.
