Comments BBC requests to permit the BHL/TD for this well to be 400' FEL of Section 4. The ability to perforate will be physically constrained by the wet shoe sub and float collar which will be located no less than 460' FEL of Section 4. BBC will not perforate or complete the wellbore within the 460' setback area of the spacing unit.

The distance to nearest completed portion of offset wellbore permitted or completed in the same formation is the Reiter 04-1H (Doc 401442210), which is approximately 236 ft away. This distance was measured in 3D.
