Basis for Review: Corrective action dates are not attainable

Operator Comment: Document number 680102416 dated 11/26/2017 indicates "Lower level of Location is In Process of Interim Reclamation." The statement in the inspection " Laramie completed reseeding at this location on November 4 & 5 2017. Laramie Energy owns the subject property. COGCC Corrective Action for reclaim of the Storage Area portion is in direct conflict with the permitted use granted by Garfield County Planning Department to the landowner (Laramie). The GARCO permit authorizes 1.49 acres for use as a Storage/Laydown Area. The current size of the Storage Area is in agreement with the permitted use (see attached). No evidence of erosion or other Storm Water issues exist. COGCC photographs attached to document number 680102416 demonstrate the Storage Area is well kept and organized. Laramie does not anticipate any interim reclamation or the need for a Variance at the Storage location.

COGCC Decision: **Not Approved**

COGCC Representative: Location is out of Compliance. Storage area has not been Reclaimed by CA Date of 6/15/17 nor has Variance been filed. Factual Review Request Doc#401167985 dated 12/15/16 was Not Approved. COGCC Supervisor Comment stated, that Storage area must be Reclaimed or Variance submitted for that part of the Location.
