According to the regulatory filings the Meis 1-8 was spudded April 27, 2001. The well was Dry/Abandoned and plugged as a dry hole. On May 1, 2003, a Subsequent Report of Abandonment Form 6 was filed. The well site has been reclaimed. The well site was reclaimed as native grass pasture. As of December 4, 2017 this location is in native grass pasture.
