Comment: It appear corrective actions from previous inspection have been performed but additional maintenance is required. The SW, W, and NW location fill slope has rilling, erosion channels, and gulley erosions. The erosion channels are 4"-18" wide and 4"-20" deep carrying stormwater and sediment off location. The fill slope remains fairly unstable creating erosion issues. Ditches, check dams, and rip rap have failed filling with sediment allowing them to be breeched and over run. The corrective action time is extended to allow for winter weather working conditions but repairs should be made as soon as possible to prevent further erosion damage.

Corrective Action: **Install or repair required BMPs to comply with Rule 1002.f.**
