##### Proposed Procedure

- 1 Leak identified with packer at 3884' MD
- 2 R/U WO rig, TIH with tubing and prepare to pump balanced cement plug.
- 3 Pump balanced cement plug at 3884' MD, Approximately 50 sks of 15.8ppg Class G cement
- 4 Squeeze cement into hole and monitor displacement
- 5 Shut down for 24 hours to let cement setup
- 6 Drill out cement plug
- 7 Pressure test casing to 2,000 psi for 15 mins to ensure squeeze has isolated leak
- 8 Rig up Wireline Service run in Owens casing patch set at depth of leak.
- 9 Pressure test casing to 4,000 psi for 15 mins with 5M BOP
- 10 Nipple up Frac Tree and test casing to 8,000 psi on surface for 30 min
- 11 Complete well and monitor pressures during stimulation.
- 12 Set a kill plug below the casing patch to isolate production interval of wellbore.
- 13 Rig up Wireline Service and fish Owens casing patch
- 14 Drill out cement plug and all plugs and land tubing
- 15 Monitor well on flowback to make sure Bradenhead pressure is not building
