The spacing unit is a 720-acre wellbore spacing unit for the Niobrara and Codell formations.



 SEC 8: W2SW4




TROTT 7W-20-8N WELL TO BE LOCATED 1543' FSL AND 786' FEL, SEC 7, T4N, R68W






TROTT 7W-20-10C WELL TO BE LOCATED 1546' FSL AND 912' FEL, SEC 7, T4N, R68W






TROTT 7W-20-12N WELL TO BE LOCATED 1547' FSL AND 948' FEL, SEC 7, T4N, R68W
