Comment: Inspector received complaint #200445538 on 3/1/2018 concerning a "white fume/plume" coming from a vent near the CIG, Latigo plant's gate on CR 38 south of Byers, CO. Contacted the complainant at ~10:30 am on 3/2/2018 and then went to the CIG Latigo plant. Met with the Kindermorgan manager at ~11:30 am. The manager thought the reboiler could be the source for the odors. No odors as described by the complainant were observed at the time of the inspection and no corrective actions were issued.
