Inspection Doc. #682501867, #675103796 and #682503002 documented and required operator to repair or remove straw wattle BMPs in disrepair on the location, remove a cattle guard identified as belonging to the operator from the access road, and to perform additional reclamation on unvegetated areas of the location. Straw wattle debris has been removed and additional reclamation activities have been conducted on location and access road. Cattle guard remains, sundry 401502788 states surface owner does not want BMP removed and is in the process of filing paperwork to accommodate request. At time of inspection, no variance has been submitted, location will remain out of compliance until variance request has been approved or BMP removed per CA.

Corrective Action: **Remove cattle guard.**
