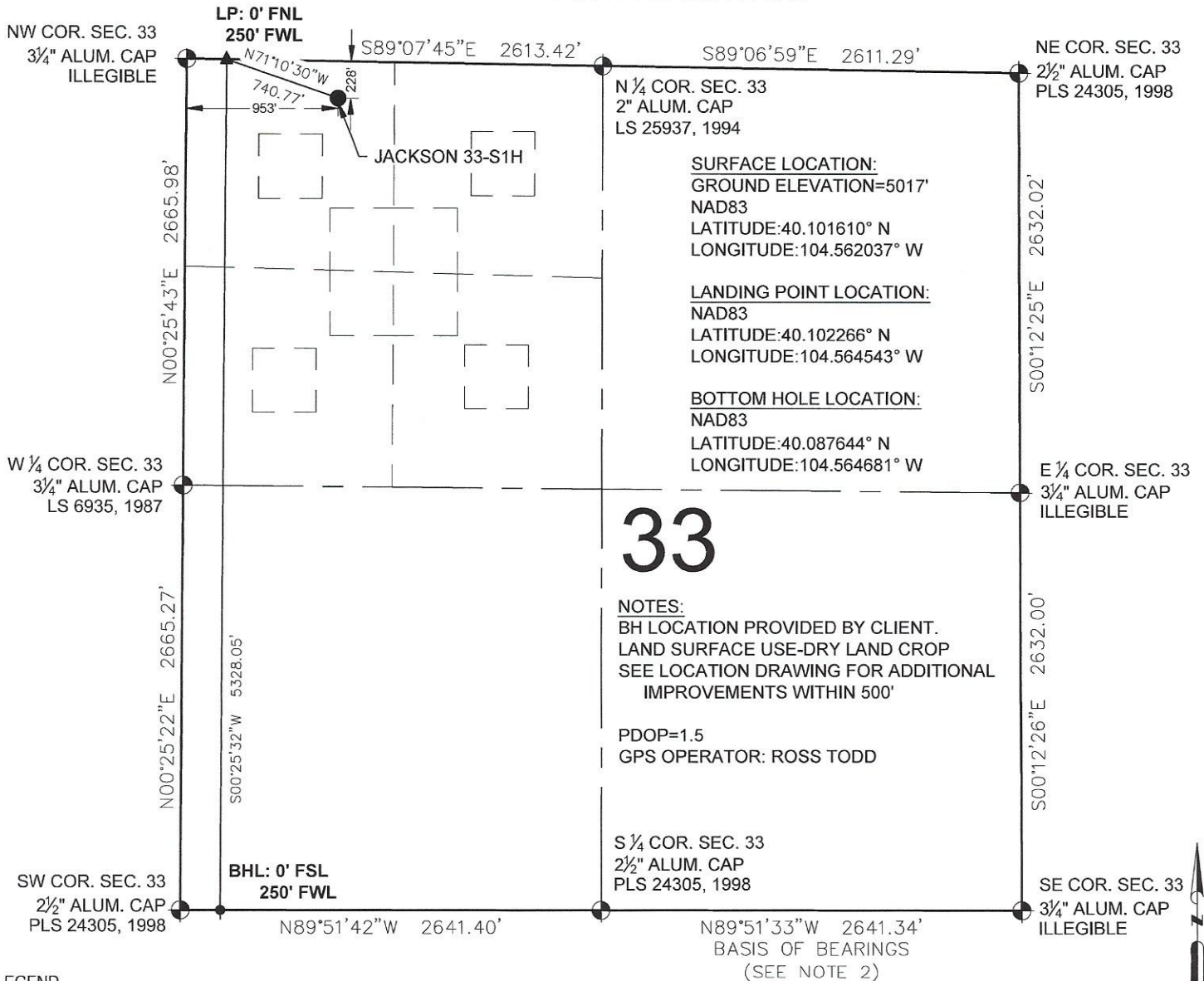


JACKSON 33-S1H WELL LOCATION CERTIFICATE
