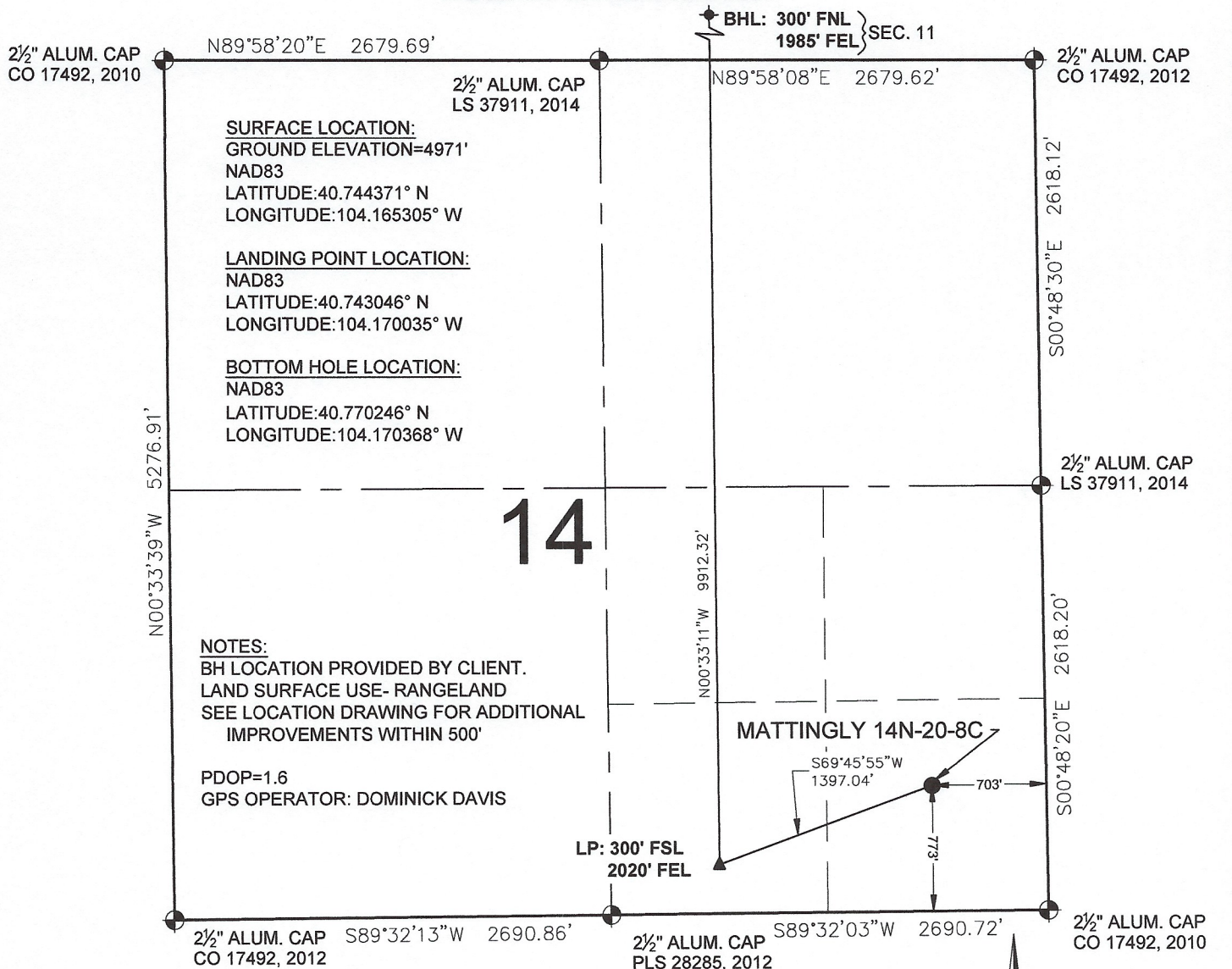


# MATTINGLY 14N-20-8C WELL LOCATION EXHIBIT

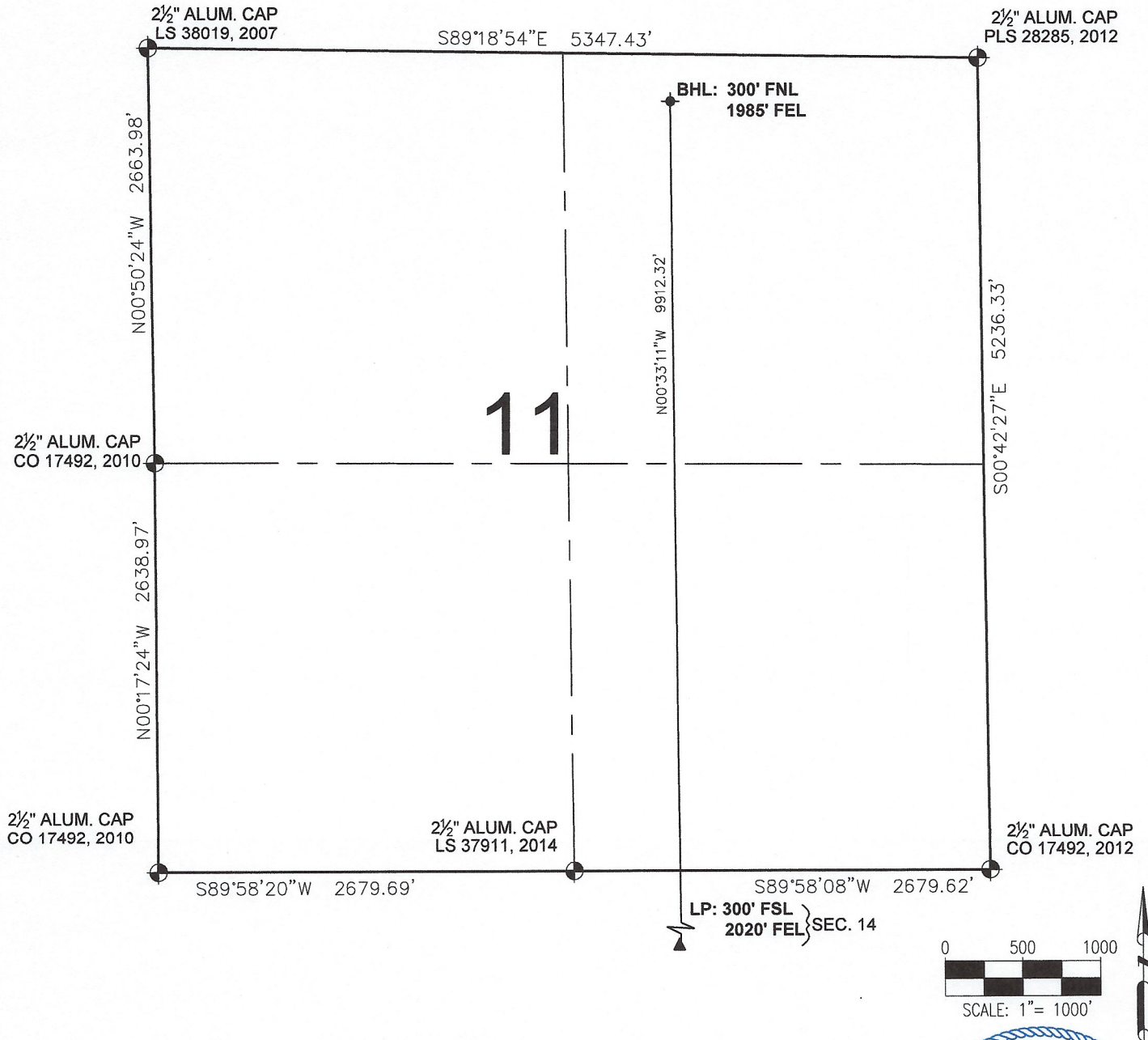
