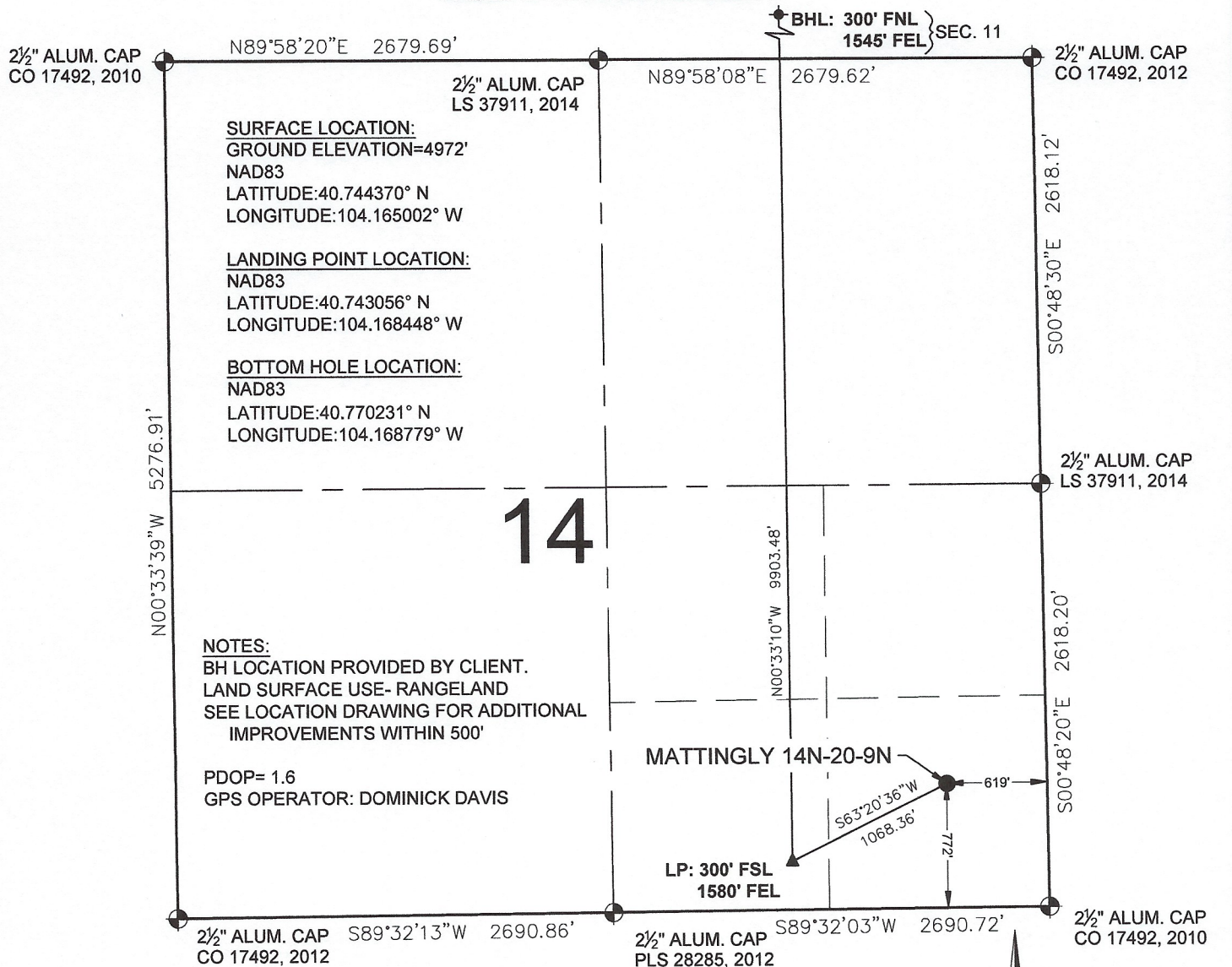


MATTINGLY 14N-20-9N WELL LOCATION EXHIBIT

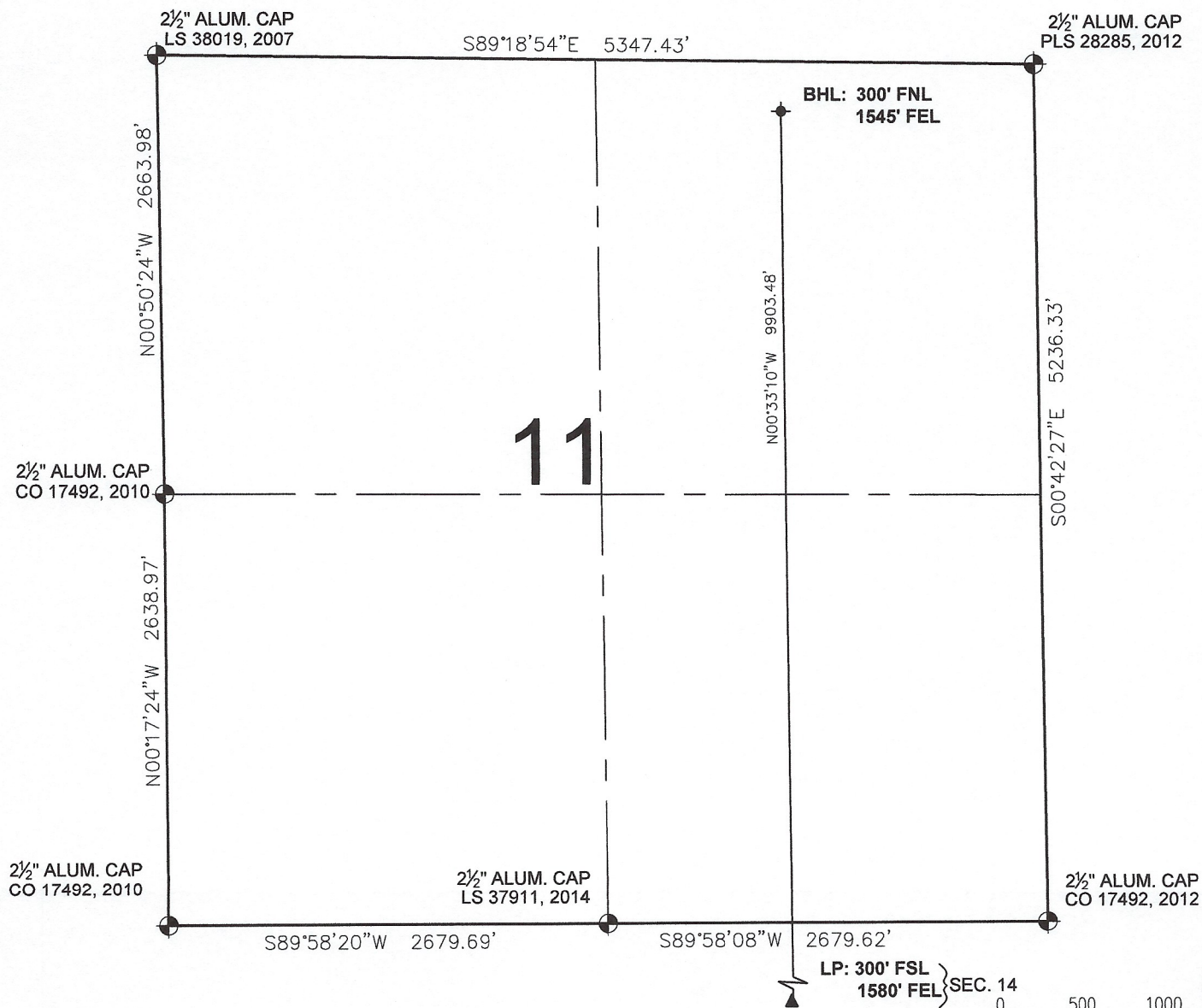
