Response: FACTUAL REVIEW REQUEST

Basis for Review: Findings are inappropriately tied to multiple wells

Operator Comment: The Hippen 1-32 (API # 123-11395) and the Pezoldt 1-32 (API # 123-15040) wells both produced to the Hippen 1-32/Pezoldt 1-32 battery (photo 7 & 8) referenced in the Inspection Document #: 682403377. While the Hippen 1-32 was plugged on 12/05/2015, the Pezoldt 1-32 was plugged on 09/08/2017 and associated facility is planned to

be reclaimed in the spring of 2018 pending gathering line riser removal. The assertion that the battery is in violation of Rule 1004.a. is false because the Pezoldt 1-32 was producing into the facility through the time period called into question by the inspector. The removal of the battery occurred within the 12 month deadline of the plugging of the Pezoldt 1-32. Ongoing monitoring and maintenance at the Hippen 1-32 still continues and the location was reseeded in the Fall on 2017. Extraction would like it noted that we have not submitted a Form 4 for approval of final reclamation because we are still maintaining the location.

Location is clearly out of compliance with the 1004 rules. As Extraction indicates the second well was PA on 9/8/2017 therefore all gathering line risers and flowline risers and surface equipment etc. should have been removed by 12/8/2017. Inspection was conducted on 3/7/2018, risers remained. Extraction should carefully review the rules.

Note: COGCC does not wait for form 4 final "reclamation complete" notices to be submitted to perform inspections. COGCC will inspect at anytime during the process to check for compliance.
