The Jurisdictional Agency determination was based on information contained in or added to the Application. Review by the professional staff of the Colorado Commission indicates that this well is an (New) ~~(XXX)~~ well. The well produces from the Codell/Niobrara reservoir(s); and was drilled after July 16, 1979.

The well is located in an area where the Codell/Niobrara formations are spaced on 80-acre units with the option to drill two wells on the unit. It is also in an area where the Codell/Niobrara has been designated tight formations by the FERC.
