Monitored natural attenuation (MNA) was initiated during the first quarter 2017 and continued through the first quarter 2018.

First quarter 2018 groundwater monitoring was conducted on March 7, 2018. Groundwater samples were collected from eight (8) Site monitoring wells (BH01 - BH08). Groundwater samples were submitted to Summit Scientific Laboratories for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX) by Unites States Environmental Protection Agency (USEPA) Method 8260B. First quarter 2018 analytical results indicated BTEX concentrations were in compliance with COGCC Table 910-1 groundwater standards for the fourth consecutive quarter. Groundwater analytical results are summarized in Table 1 and illustrated on Figure 1.
