Proposed Procedure:

1. MIRU service unit, kill well.
2. NU BOP and test.
3. POOH 2-3/8" tubing.
4. RIH with 4-1/2" RBP and packer.
5. Set RBP at 4,350' and test, Dump 2 sx sand on top of RBP.
6. Set packer +/-100' above top perf at 4,127'
7. Squeeze MV-4 perforations with Class G cement.
8. POOH tubing and packer.
9. Allow 24-48 hrs cement set time.
10. RIH with bit and drill out cement to top of RBP.
11. Pressure test cement to 1,000 psi. POOH.
12. RIH and retriive RBP. POOH
13. RIH production string.
14. RDMO and return well to production.
