Type of Spill: PRODUCED WATER

Estimated Spill Volume: 25

Comment: Followup to spill report of 3/5/18. Weather is 23F and clear. 2-3 inches partial snow cover. Spill was from 6x400 bbl tank battery into poly-lined, steel SPCC. No visible indications of a release outside of containment. Spill report stated that all fluids were recovered and F-19 was closed, however ~3-4 inches of oily, frozen, pw/precip is pooled on NW side of tank battery.

Corrective Action: Pump all residual fluids back into storage tanks as soon as weather conditions allow. Document final clean-up with corrective action report.
