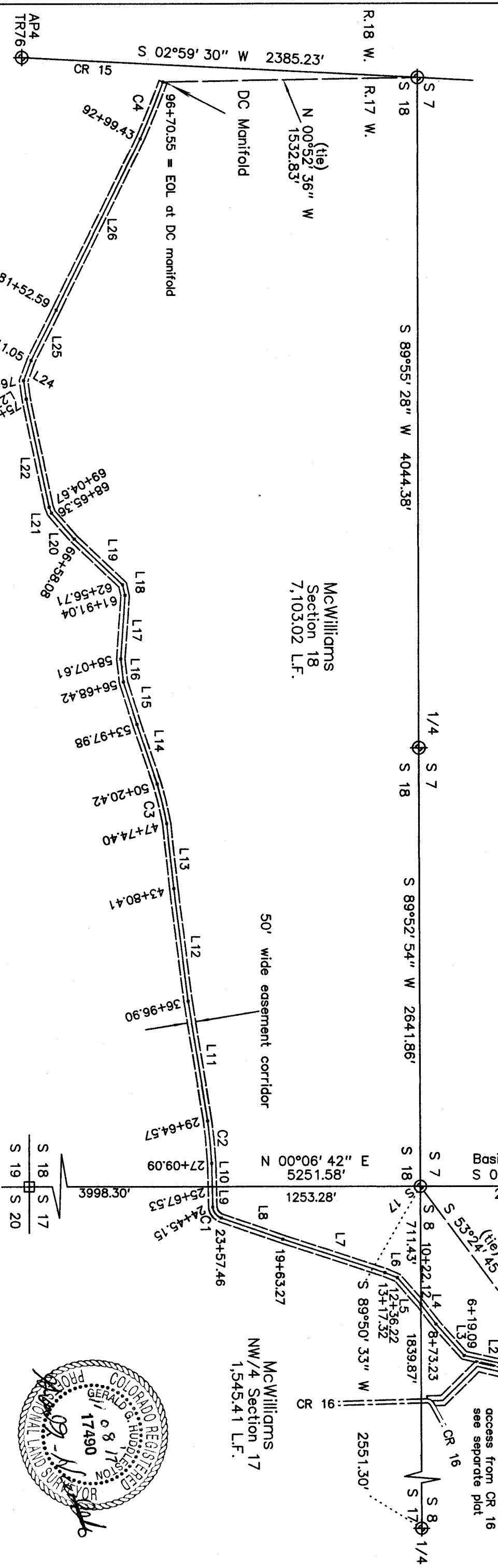

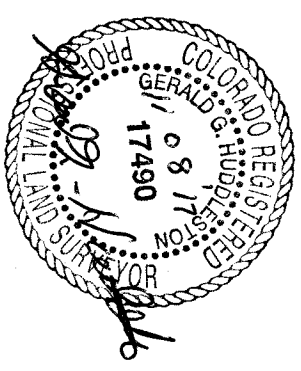

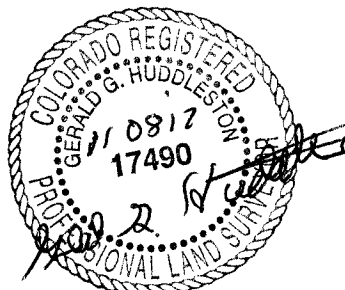
LEGAL DESCRIPTION – 50 Foot Wide Easement Corridor on BLM

Beginning at a point on said 50 foot wide easement corridor centerline from which the SW Corner of said Section 8 bears S 53°24'45" W a distance of 1449.23 feet; thence South 14°07'54" West a distance of 392.76 along said centerline; thence South 12°23'51" West a distance of 226.33 feet along said centerline; thence South 48°26'28" West a distance of 254.14 feet along said centerline; thence, South 52°09'31" West a distance of 148.89 feet along said centerline to a point on the South line of said SW/4 of said Section 8 and the end of said 50 foot wide easement corridor, from which point the SW Corner of said Section 8 bears S 89°50'33" W a distance of 711.43 feet. SUBJECT TO all easements of record or prescriptive.
