Bill Barrett Corporation (BBC) is planning to drill the well(s) on Exhibit A to the Niobrara formation.

The surface location of BBC's proposed well(s) has been staked outside of the 318A.a drilling window. The location is being permitted as an exception location. The surface owner has waived Rule 318A.a within the Surface Use Agreement.

Under revised Rule 318A.c any new twinning well is to be located within 50' of an existing well(s). The surface location of BBC's proposed well has been staked further than 50' from the nearest oil & gas well. The surface owner has waived Rule 318A.c within the Surface Use Agreement.

Thank you for your attention to the enclosed. BBC respectfully requests that the COGCC review the enclosed information and approve the requested exception location waiver and application for permit to drill the captioned well.
