Comment: Followup to assess passive SVE remediation system installed under REM 10745. Weather clear, 40F. A total of six wind turbine-powered SVE extraction wells have been installed in close proximity and enveloping the single boring location where Table 910-1 was exceeded for benzene. Wells are screened at intervals below through above the benzene detection. Wind at 1-5 mph. All turbines spinning freely. No noticable odor detected from any of the turbines.

Corrective Action: Continue O&M of SVE system until future soil boring confirmation samples indicate compliance with Table 910-1 concentrations.
