Disposal Description: (Drilling Waste Management)

Laramie plans to drill the wells within this project boundary with a dewatering system with no need for a reserve pit. Drilling fluids are recycled and re-used with cuttings being de-watered and captured in a catch pan, stacked in a cuttings management area and allowed to dry. Once the cuttings are dry and satisfy the COGCC for Rule 910 analytics, the cuttings will be stacked along the cut slope then buried and covered with a minimum of 3 feet of cover. This operation will occur after the completion of all the wells.

Drilling fluids will be sent to the Central Water Handling Facility for re-use via the newly installed leg-off pipeline or truck.

The Shell 797-14-01D pad is an existing pad with 1 producing well (Shell 797-14-01D, 045-12399), and approved permits for 4 wells. A new well will be added (0797-10-10E) and 1 well (TC 797-15-01E, 045-23336) will have the name and BHL changed for which a sundry (doc #401539701) is being submitted. An updated multi-well plan for the pad will be submitted via sundry doc #401539750. There are no other changes to the existing location or existing access roads.

Laramie Energy will comply with the Notice to Operators (NTO) Drilling Wells on the Roan Rim Plateau (June 12, 2008).
