DESCRIPTION

Provide a detailed description of the accident, problems, and cause (equipment failure, human error, etc.): actions taken to provide well control in detail):

At approximately 7:45-8:00 AM MDT, a contract farmer, while tractor plowing for the surface owner WELDCO Farms, collided with the Bayswater operated Dyer 2-24 wellhead causing a rupture to the piping at the south facing casing valve. It is not know why the wellhead was hit by the farmer as the wellhead was clearly marked with red fencing panels surrounding the well with a orange flag that extended significantly above the wellhead. The rupture resulted in an uncontrolled flow of the well to the atmosphere through the exposed south facing casing valve opening. The Galeton Fire District was dispatched to the well location. Bayswater personnel also were dispatched to the scene. The site situation was assessed. Weather conditions were clear with mild wind from the NE. Although the well flow was essentially contained within the plowed field, as a safety precaution, the owners of nearby residences to the south and west of the well location were notified. WCR 57 between WCR 72 and WCR 74 was closed to prevent traffic from traveling to south and west of the well flow. Well control experts were dispatched to the scene and arrived at approximately 3:00 PM MDT. After further assessing the situation, the well control contractor proceeded to replace the damaged casing valve and had the well shut in and controlled at approximately 4:00 PM MDT 3-12-2018. There were no personal injuries incurred as a result of this incident. Clean up and remediation operations were commenced immediately after well flow was shut in. A workover rig was moved in on 3-13-2018 to make necessary wellhead repairs. Soil clean up and remediation operations will continue until complete and are reported on COGCC Form 19.
