735.07 Acres

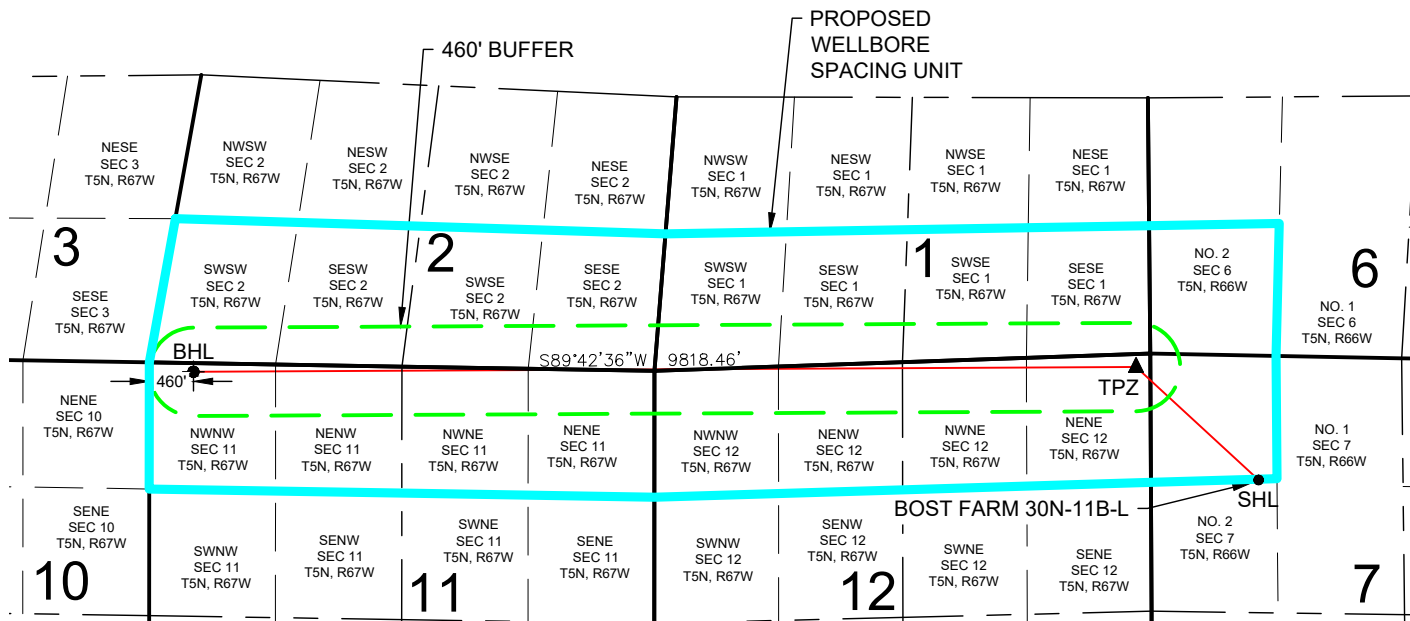

The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. BOST FARM 30N-11B-L WELLBORE SPACING UNIT

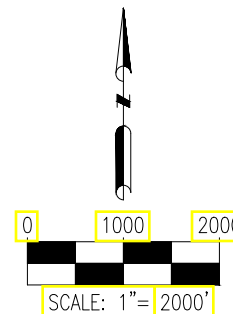


BOST FARM 30N-11B-L WELL TO BE LOCATED 1295' FNL AND 1122' FWL, SEC 7, T5N, R66W
