Comment

Revegetation needs to be monitored. Vegetation has largely failed on Cut slopes with sediment migration occurring. Vegetation is sparse on Fill slopes with erosion occurring on steep Fill slope area towards bottom of slope base.

Corrective Action

Reseed or inter-seed in areas of Interim Reclamation where desirable vegetation has failed to emerge or establish. These areas will need additional stabilization until vegetation establishes, being sure to address erosion towards base of Fill slope.
