On 2-20-2018, I was contacted by complaint specialist Megan Adamczyk in reference to some complaints received by the COGCC in reference to noise, lights and odors. The complaint stated the issues were occurring in the Brighton area originating from the Verdad, Homestead location.

On 2-23-2018, I attempted to make contact with the complaint she indicated in her complaint she was experiencing noise lighting and odor issues coming from the Verdad Homestead location. I performed a complete site inspection of the Verdad location. I reviewed location records, which did not show any abnormal fracking conditions at the time of the complaints. I reviewed third party sound records at the times of the complaint and at no time did the drilling operation exceed COGCC rules according to the sound study information reviewed. I checked the area around the complaints residence at the time of the inspection I did not detect any odors at the time. At the time of the inspection all lighting appeared to be [pointed down and toward the ground per COGCC rules.

No violation of COGCC rules were observed at the time of the inspection of the frack operation nor in the surrounding neighborhood.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
