INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On May 1, 2014, historical impacts were discovered during tank battery removal activities at the Howard 25C-22HZ production facility. The facility was shut in, and excavation activities were initiated. Groundwater was encountered in the excavation area at approximately 4 feet below ground surface (bgs). The COGCC has issued Spill/Release Point ID 437084 for this release.

Soil samples were collected as described in the Initial Form 27. Based on the data presented, impacted soils in the excavation area were remediated to be in full compliance with State standards.

Proposed Groundwater Sampling

- ☒ Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Between November 10, 2014 and March 28, 2017, eleven (11) temporary monitoring wells (BH01 - BH10, BH07R) were installed to further assess the extent of groundwater impacts. Quarterly groundwater sampling was initiated at wells BH01-BH03 on November 20, 2014, and was temporarily suspended after one event to allow for additional well installation. Quarterly groundwater sampling resumed on June 30, 2016, and is ongoing. Groundwater samples are collected from the remaining ten (10) temporary monitoring wells at the site (BH07 was consistently dry and was destroyed following replacement well installation) on a quarterly basis and analyzed for benzene, toluene, ethylbenzene, and total xylenes (BTEX). Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 1. Laboratory analytical reports are included as Attachment A.

Hydrocarbon impacted groundwater remains at the site. The 10 remaining temporary groundwater monitoring wells (BH01 - BH06, BH07R, BH08 - BH10) will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards for four consecutive quarters. Additional temporary groundwater monitoring wells will be installed to maintain point-of-compliance.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Between May 1 and 7, 2014, approximately 220 cubic yards of impacted material were excavated and transported to the Front Range Regional Landfill in Erie, Colorado. Approximately 50 barrels of impacted groundwater were removed from the excavation area via vacuum truck and transported to a licensed disposal facility.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory data indicate that impacted soils in the excavation area have been remediated to be in full compliance with State standards. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in full compliance with State standards for four consecutive quarters. Additional potential remedial activities will be evaluated as appropriate. Estimated time to attain NFA is TBD based on the review of groundwater concentrations, the extent of impacted groundwater, and the efficacy of selected remedial technologies.

GROUNDWATER MONITORING

Between November 10, 2014 and March 28, 2017, a total of 11 temporary groundwater monitoring wells were installed at the site to assess the extent of groundwater impacts. Temporary monitoring well BH07 was consistently dry, and was replaced by well BH07R. The remaining 10 temporary monitoring wells will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards for four consecutive quarters. Additional temporary groundwater monitoring wells will be installed to maintain point-of-compliance. Groundwater sample locations are illustrated on Figure 1, and a potentiometric surface contour map for the Fourth Quarter 2017 is presented as Figure 2. Well completion logs for the temporary monitoring wells are included as Attachment B.
