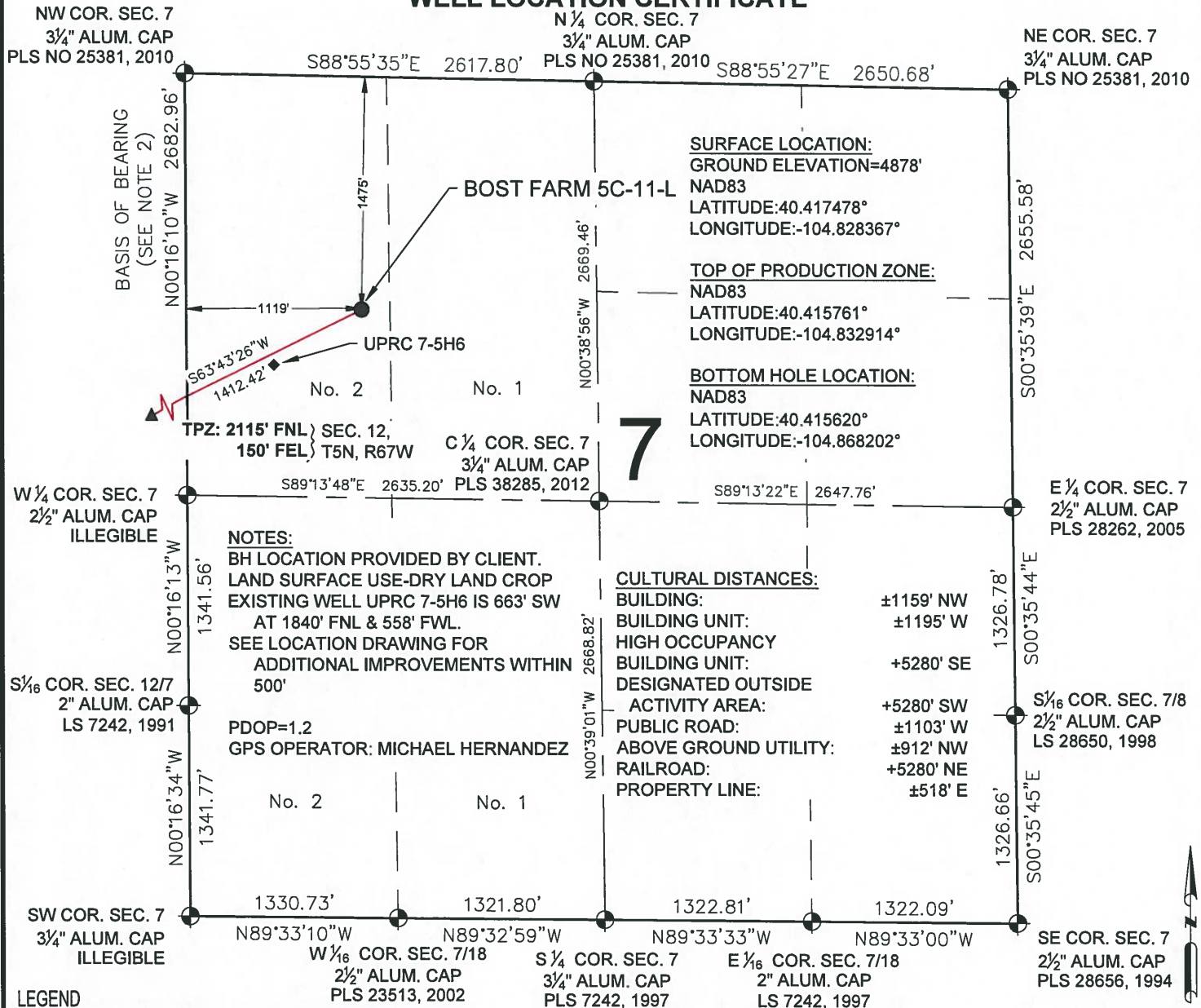


# BOST FARM 5C-11-L WELL LOCATION CERTIFICATE

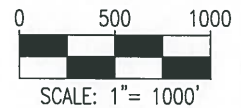
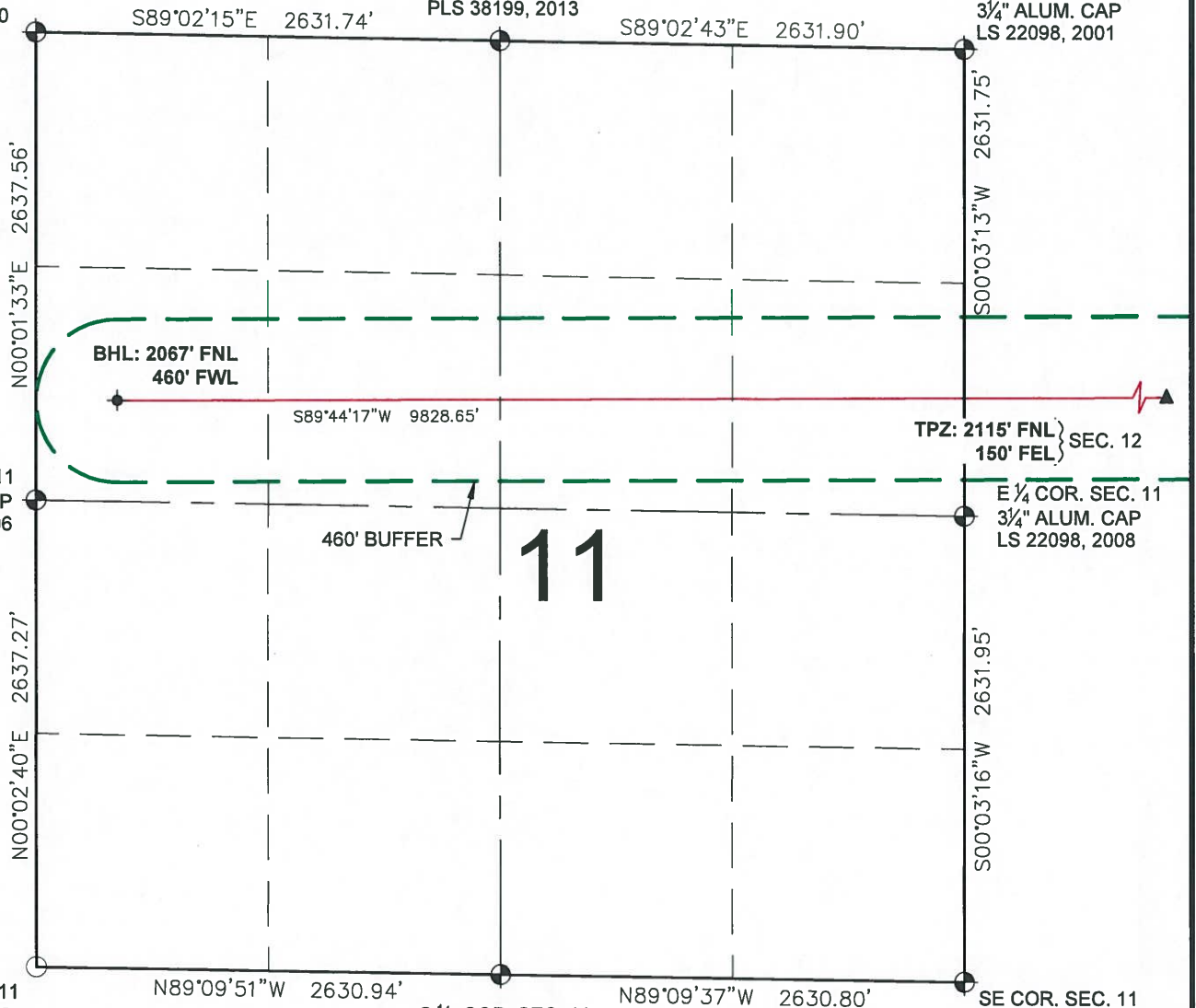
