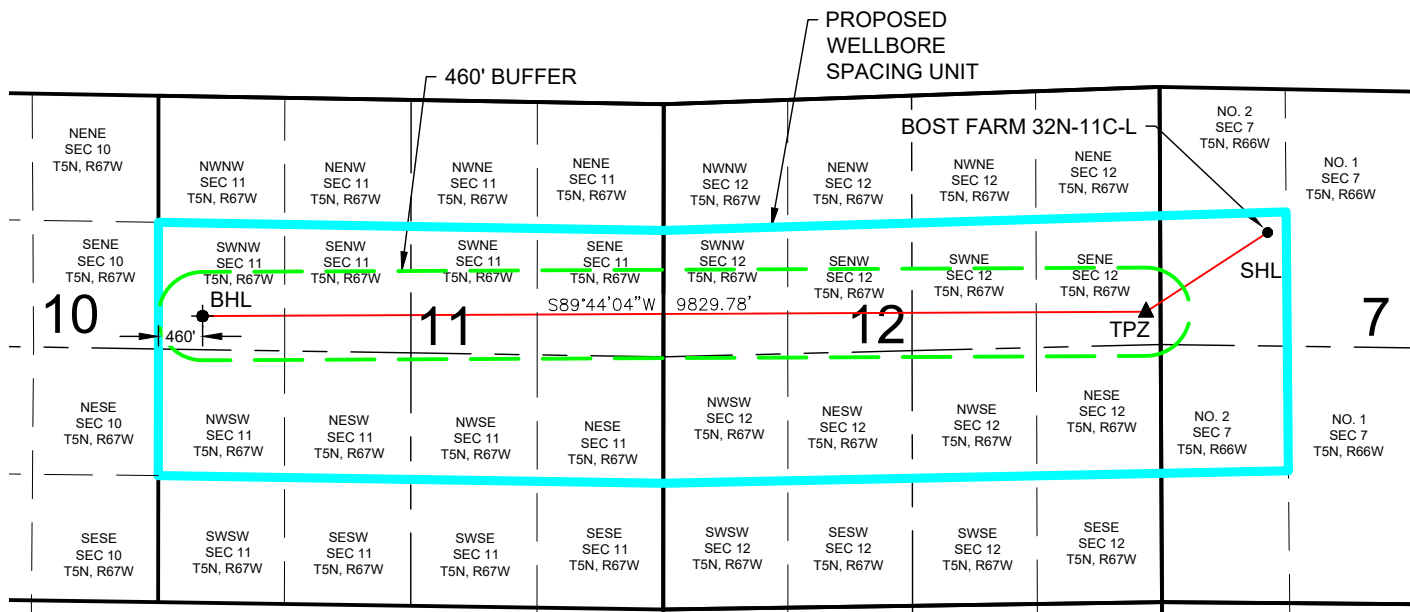

BOST FARM 32N-11C-L WELLBORE SPACING UNIT

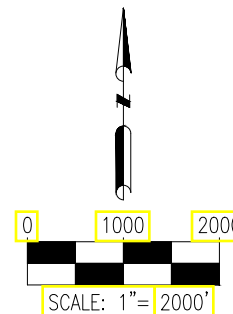


BOST FARM 32N-11C-L WELL TO BE LOCATED 1495' FNL AND 1119' FWL, SEC 7, T5N, R66W
