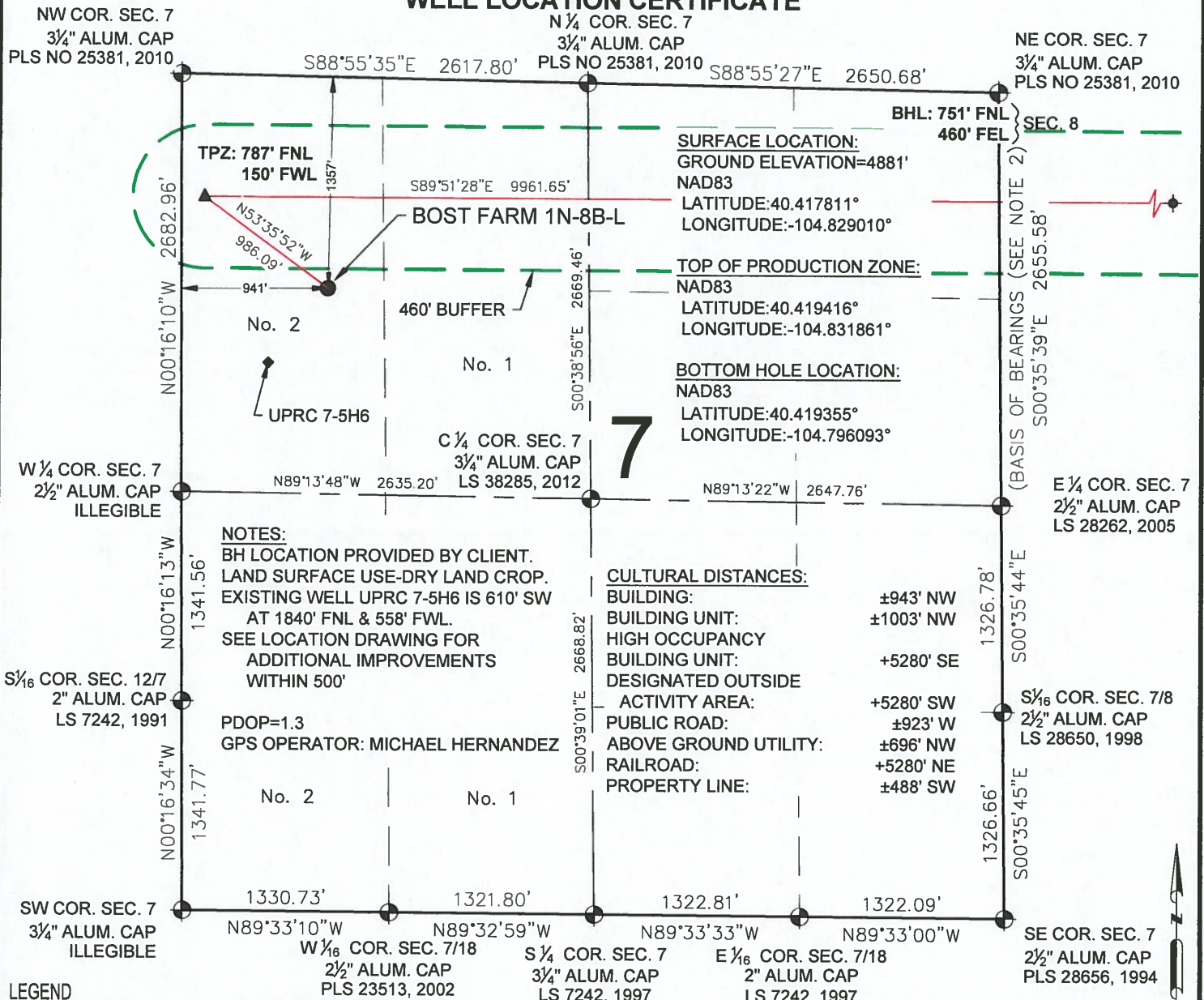


# BOST FARM 1N-8B-L WELL LOCATION CERTIFICATE

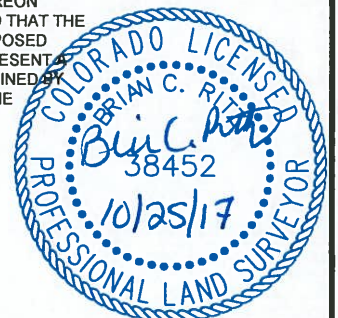

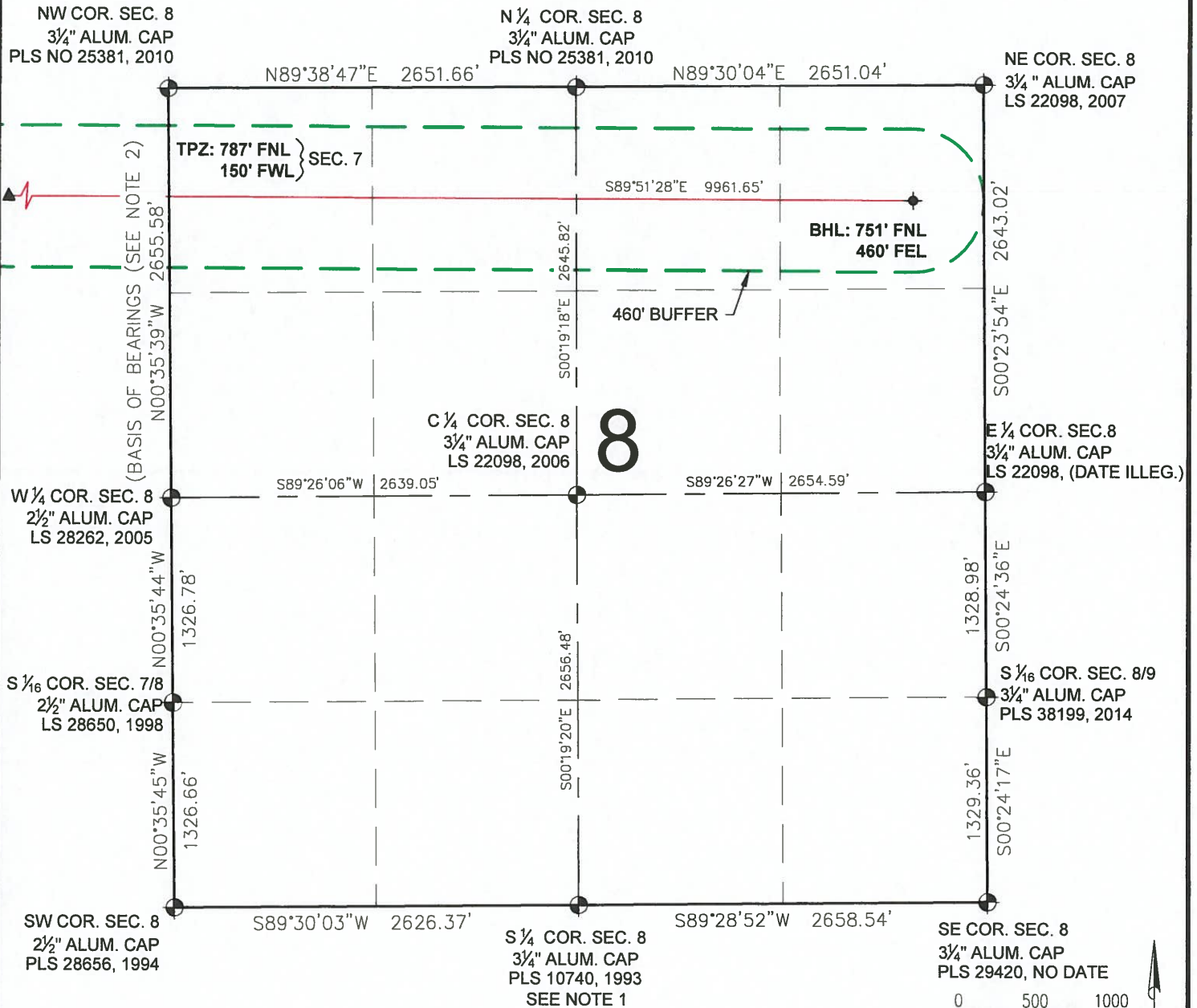
