COMMENTS:

Enerplus Resources respectfully requests the Elizabeth Miller 1, API #05-123-08000, be removed from the COA for the wells listed below. This request is based on the location and proximity of the Elizabeth Miller 1 to the proposed wellbores with a cement plug from 375' to 600' covering the surface casing shoe and the base of the Fox Hills. The Elizabeth Miller 1 is located 1,250'-2,930' from the toes of the proposed wells. Due to the tendency of fractures to grow perpendicular to the wellbore and the Elizabeth Miller 1 being located at the toe of the proposed wells in an undeveloped area with native reservoir pressures there is a low risk of communication from the proposed wellbores.
