Noble respectfully submits this proposed location assesment. Producing at BB06-33 Production Facility located approximately 668' South. The Exception Location and Twinning Waiver language is included in the attached SUA.

Form 2 Doc #401425638 is still currently in draft form awaiting a stimulation setback waiver 317(s) to be received by 3/26/2018.

Mitigation - Brush hog or mow Aug 1 – March 31. Conduct avian nest surveys within 50' of disturbance 2-3 days prior to ground clearing for MBTA compliance March 1 – July 31. Raptor nest clearance survey within 0.5 mile prior to construction, drilling, and completions operations initiated between Feb 1 – July 31.

Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil & Gas operations throughout the state of Colorado in accordance with CFR 112.
