Comment:

Location has not been fully reclaimed; gravel remains on site and area has not been decompacted or properly revegetated.

Site is immediately adjacent to lease road that appears to lead South to access one PR Well. The site's close proximity to the road, narrowness of the Location & road at this point, make it valuable as a turn out point, leading to the conclusion that Location should be fully reclaimed upon PA of the well to South (071-08614) and reclamation of the road. Status of overall Final Reclamation will be left Blank at this time. Operator should continue to monitor & manage site for Stormwater and Weeds.

At this time there is just one erosion issue that is entered in Stormwater section that needs to be addressed.
