TEP Rocky Mountain LLC would like to report the following updates to the Federal RGU 33-24-198 pad due to proposed well recompletion operations.

Water will be supplied to location through existing infrastructure and a proposed 10 inch temporary surface water supply line (approx. 2578 ft.), which will be installed from the NE Ryan Gulch Pit 31-25-198 (Facility ID #433759) to the RGU 33-24-198 pad following the existing access road. The temporary surface line will be installed entirely within previously disturbed areas, and be removed immediately following completion of frac operations. Two additional tanks will be added to the existing tank battery for a total of 2-500 bbl condensate tanks and 4-500 bbl water tanks. The existing Emissions Control Device (ECD) will be relocated 75 ft. to the southeast of the existing tank battery, west of the existing access road. One 4 inch surface pipeline (approx. 75 ft.) will be installed between the tank battery and the ECD. All disturbance activities will be contained within the previously disturbed limits of the pad location.

An updated construction layout plat and Plan of Development for the RGU 33-24-198 pad is attached.
