Field Inspector Actions:

On 3-9-2018, I was contacted by complaint specialist Megan Adamczyk in reference to some complaints received by the COGCC in reference to noise and odors, the complaint stated the issues were occurring in the Erie area at the Extraction, Coyote location.

On 3-9-2018, I attempted to make contact with the complaint who had indicated in her complaint she was experiencing noise and odors coming from the Coyote drilling location. I performed a complete site inspection of the Coyote location. I reviewed location records, which did not show any abnormal drilling conditions at the time of the complaints. I reviewed third party sound records at the times of the complaint and at no time did the drilling operation exceed COGCC rules according to the sound study information reviewed. I checked the area around the complaints residence at the time of the inspection I did not detect any odors at the time.

No violation of COGCC rules were observed at the time of the inspection of the track operation nor in the surrounding neighborhood.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
