On 3-26-2018, I was contacted by COGCC staff in reference to some complaints received by the COGCC in reference to noise, the complaint stated the noise was occurring in the Erie area originating from the Extraction, Coyote location.

On 3-26-2018, I contacted the complaint she indicated she was experiencing noise coming from the Coyote drilling location. I performed a complete site inspection of the Coyote location. I reviewed location records, which did not show any abnormal drilling conditions at the time of the complaints. I reviewed third party sound records at the times of the complaint and at no time did the drilling operation exceed COGCC rules according to the sound study information reviewed.

No violation of COGCC rules were observed at the time of the inspection of the track operation nor in the surrounding neighborhood.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
