Soil samples will be collected from the locations proposed on the attached map and analyzed for BTEX, TPH, EC, SAR, and pH. Should any of the samples exceed the Table 910-1 standard, soil will be removed from the impacted area until a clean sample is obtained. Any soil removed from the pit due to impacts will be taken to the Waste Management Ault facility.
