The required thirty (30) day notice period has elapsed absent the receipt by Crestone of an objection to said proposal by the owner(s) within the proposed spacing unit for this well.

Thank you for your time and attention to this matter. Crestone respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.



