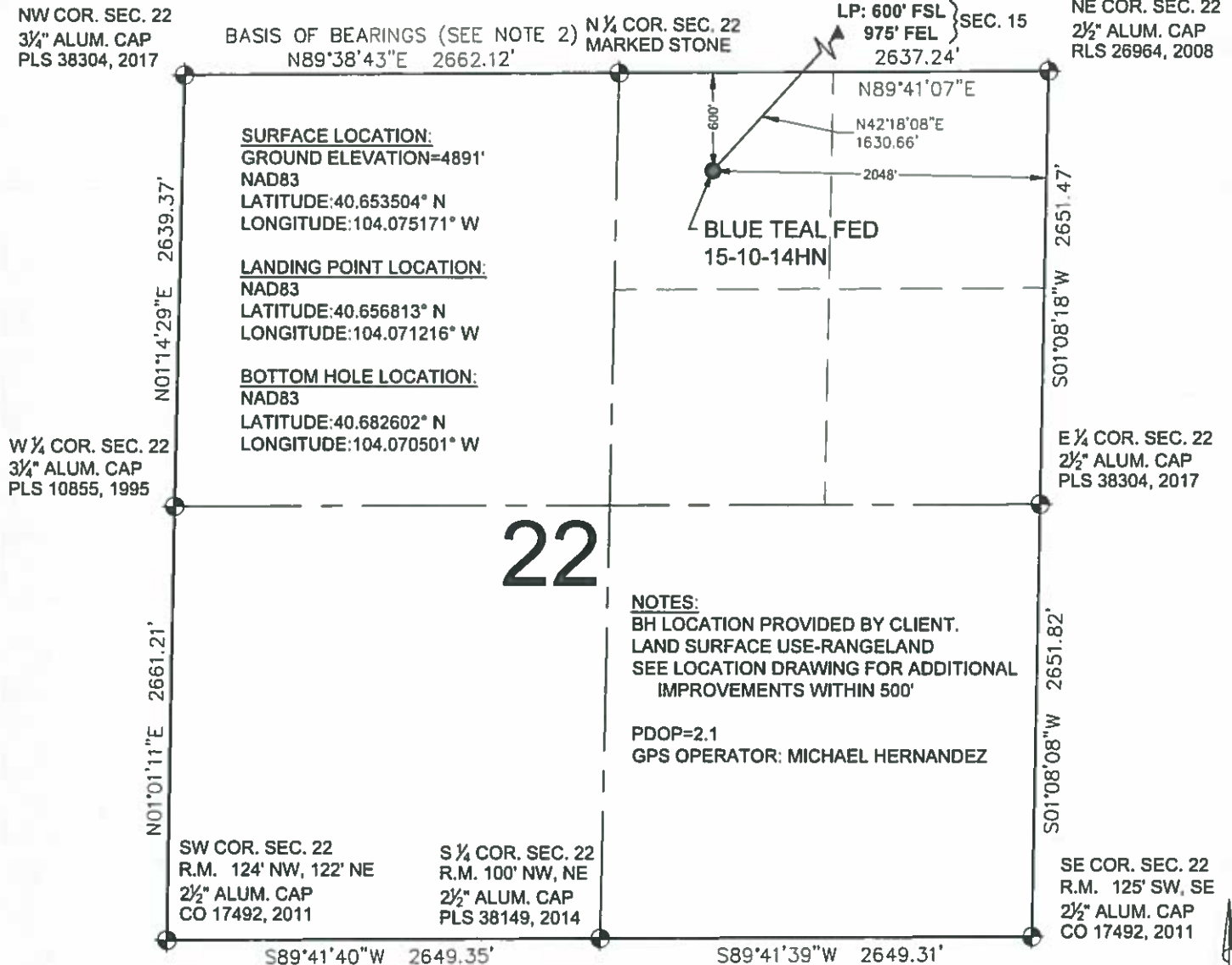


# BLUE TEAL FED 15-10-14HN WELL LOCATION CERTIFICATE

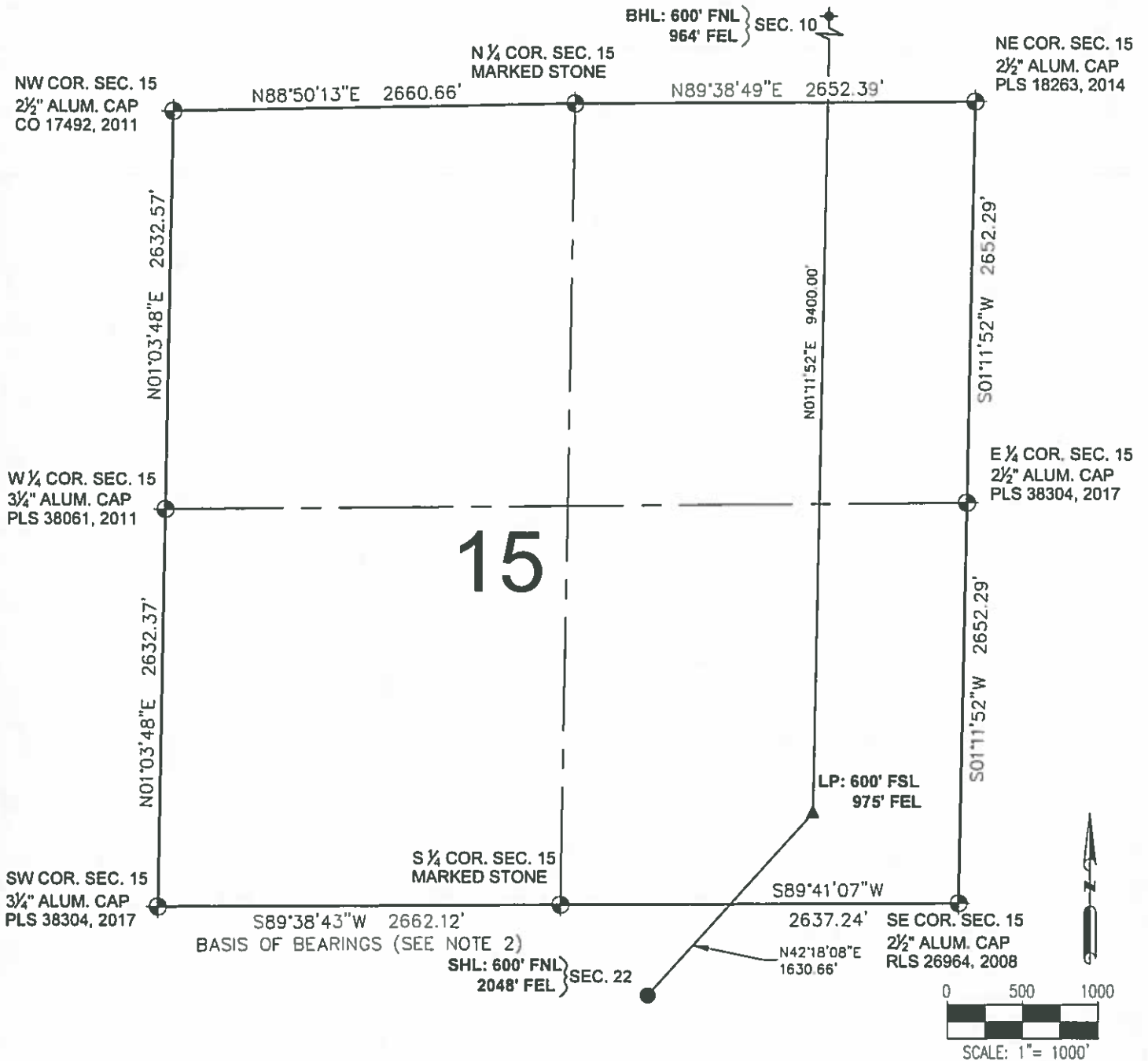

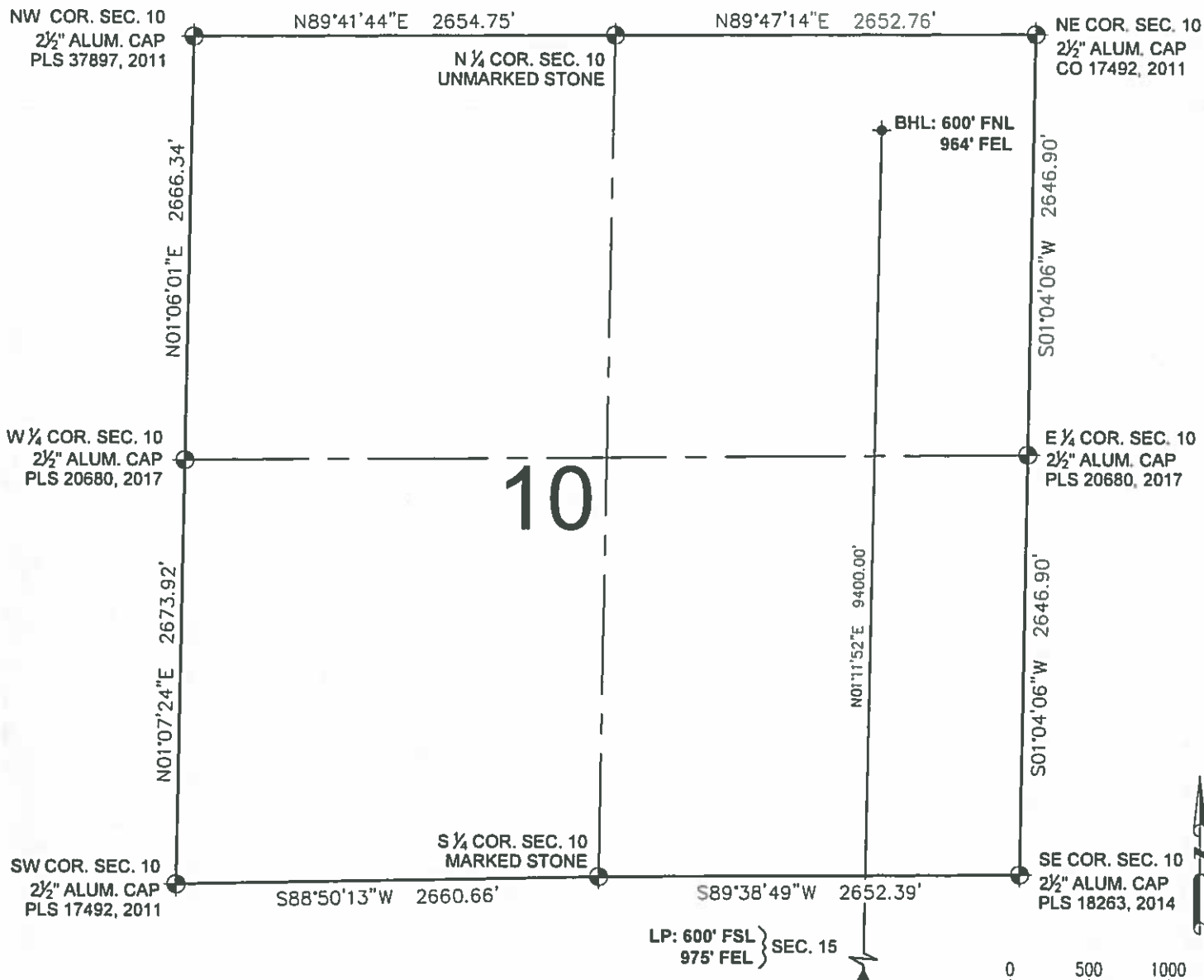
