TEP is requesting installation of a temporary 300 bbl low profile tank on the RWF 324-9 to produce condensate for up to 6 months. TEP was pressure testing the condensate line that flows from RWF 324-9 pad to the Clough 104 Tank Farm and the line test failed. The line is on Fee lands and TEP is currently working on a solution to replace/repair the line. Once the line is repaired/replaced, TEP will resume the collecting and measuring condensate on the Clough 104 Tank facility.
