

DATE	DAY WORK	REMARKS
11-24-86	8 hours	Moved rig on well. Raised mast. Bled off gas.
11-25-86	10 hours	Had to look for water. Ran sand. Loaded hole. Water truck, 8 hours.
11-26-86	6 hours	Checked in on sand. Plug at 2500'. Stuck wire line. Dug cellar.
12-01-86	10 hours	Rigged up jacks. Worked pipe to 55". Worked wire line loose. Tried to pump well with water. Water truck, 8 hours.
12-02-86	10 hours	Checked in on plug. Went from 2500' to 4600'. Worked pipe. Still 55".
12-03-86	10 hours	Drove plug from 4600' to 7300'. Set 5 sacks cement at 7300'. Water truck, 3 hours.
12-04-86	10 hours	Ran sand from 7300' to 7100'. Loaded hole. Water truck, 6 hours.
12-05-86	8 hours	Loaded hole with water. Set 5 sacks cement on sand at 7100'. Water truck, 6 hours.
12-08-86	10 hours	Worked pipe. Ran a shot to 6500'. Worked pipe. Ran a shot to 5500'. Worked pipe. Ran a shot to 5000'. Worked pipe. Made from 55" to 58".
12-09-86	10 hours	Worked pipe. Ran a shot to 4500'. Worked pipe. Ran a shot to 4000'. Worked pipe. Ran a shot to 3300'. Came loose. Pulled 21 joints.
12-10-86	8 hours	Pulled casing. Tore down jacks and rig. Set 25 sacks cement at 315'. Mudded to 28'. Set 10 sacks cement to base of cellar. Welded on cap.
