Comment: The BMPs (diversion ditch and berm) appear sufficient during topsoil salvage and initial pad construction operations. However, berm BMP material has been left unconsolidated. Operator shall ensure to stabilize the berm BMP, as an unconsolidated berm is not a properly functioning BMP. Culverts are being installed at both entrances to the location. Operator should consider installing a vehicle tracking pad during all construction activities to prevent potential tracking off location. More permanent BMPs should be installed upon the completion of pad construction. A follow-up inspection will occur at a future date to ensure the Operator is in compliance with Rule 1002.f. standards.
