Further soil borings are needed to delineate extent of impacts. Two additional delineation wells are scheduled to be installed the week of 4/16/18. Following delineation, several remedial options will be considered.

Currently additional monitor wells are proposed to be installed to complete the delineation of the groundwater impacts to the northwest of the site. Remaining soil impacts at the source area are planned to be remediated via insitu due to the depth they occur. In addition, PSH will be recovered via hand bailing and/or an automated skimmer system. Additional remedial alternatives will be evaluated as site conditions change.
