Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a CIBP set at 6,646' on 4/17/2017 for an off-set frac. Noble will return the well to production once the off-set frac is complete and a rig is available. Noble will run an MIT if the well is still AB after two years. Attached is the initial pressure documentation an MIT was not run however the wellbore was pressured to 1500 psi and held for 15 minutes.
