Five discreet confirmation soil samples were collected (4 wall and 1 base) and analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). Concentrations of BTEX, GRO, and DRO were not detected at or above laboratory reporting limits. See the attached laboratory report, soil analytical table, and Figure 3.
