1. MIRU pulling unit. Pull 2 3/8" tubing if present.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6712'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6405'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with tubing to 2885'. RU cementing company. Mix and pump 20 sxs 15.8#/gal CI G cement down tubing to 2640'. TOOH with tubing.
6. TIH with casing cutter. Cut 4 1/2" casing at 750'. Pull cut casing.
7. TIH with tubing to 844'. Mix and pump 359 sxs 15.8#/gal CI G cement with 2% CaCl2 down tubing to surface.
8. Cut surface casing 6' below ground level and weld on cap
