Comment:

Previous inspections documented that crop vegetation growth over the battery location is stunted when compared to the adjacent areas, and that this is likely due to compaction concerns. The inspection required operator to perform additional reclamation. Operator (via email) submitted notice to inspector that additional work has been conducted and corrective action addressed. Crop field currently fallow; it is unclear as to what additional reclamation activities have been conducted. A follow-up inspection will need to be conducted once crop has become established to determine compliance with reclamation standards and requirements.
