SG proposes to use salt based drilling >15,000 ppm Cl fluid to drill the 3 permitted laterals/sidetrack at this location. Fluids of approximately 9.5#-9.8# with approximately 125,000 ppm Cl will be used to drill the laterals/sidetrack. A Sundry (doc# 401320426) was previously submitted and approved to use salt based drilling at this location, however the sundry was specific to drilling one sidetrack. SG would like to make it clear that salt based drilling will be used to drill all three laterals/sidetrack (API - 05-051-06061-01, 05-051-06061-02, 05-051-06061-03). SG agrees to the COA's as placed on the previous sundry. Sundry Forms will be submitted concurrently to modify the Form 2's to include salt based drilling.
