During completions operations on the North Platte K-22 pad at approximately 8:00 am on 4/19/2018, we found bradenhead pressure on the Perkins 21-22.
Below is what we have agreed with the COGCC to do to immediately remediate the well, which was verbally approved on 4/19/2018. Longer term we will likely plan to file paperwork to fully plug and abandon this well.
On 4/19/2018 we set a CIBP at 6303' (~80' above top perf at 6384')- topped with 25 sks Class G cement.
