During completions operations on the North Platte K-22 pad at approximately 12:00 pm on 4/13/2018, we found bradenhead pressure on the Perkins 32-22.
Below is what we have agreed with the COGCC to do to immediately remediate the well, which was verbally approved on 4/13/2018. Longer term we will likely plan to file paperwork to fully plug and abandon this well.
On 4/14/2018 we set a CIBP at 6285' (~75' above top perf at 6360')- topped with 25 sks Class G cement.
Details and third party tickets for this work will be submitted on a Form 5A.
